We start this year off with Travis Brady, Travis was out early and has been rewarded for his efforts. He jerked up two lunge, a 31 from Shabbona and a 32 from the Madison Chain. That makes Travis the current leader in the Men's division. Next we have Dick Cholke. Dick was also out early and hit North Spring. He set a trap, in fact a rattle trap and stuck a 34. Our next fish was caught on opening day and was spooked up by our President Jeff Blanck. Jeff was able to coax a 41-incher into munching his offering. Also on opening weekend of Wisconsin but in Illinois, Jeremy Venhuizen had a story to tell. In fact his tale of tail's was a nice 35.5 caught on Lake Storey. I thought it was fiction but in fact I saw a picture so I guess it was the truth. Our final fish that was turned in is from Mike Kruger. Mike was out looking for a beast when a 37.5 incher destroyed his bait. And when I say destroyed it I mean it. I was able to net the beast and after a head shaking from hook set to bottom of the net, the bait had both hooks bent, one screw eye twisted open and one bard snapped off at the shank. Quite the aggressive fish.

### Next outing: Squaw and Squirrel

We had an outing on Squaw Lake two years ago and it was a good one. Eight fish were caught with Tim Scruggs' 40-incher as the biggest. Squaw Lake is a 736 acre lake located in Oneida County. It has a maximum depth of 21 feet. It's an action lake, but there have been reports of 50-inchers being caught. There are so many muskies in the lake, the size limit was lowered to 28 inches to reduce the population density. Unfortunately, we will not be able to stay at the same cabin we did in 2013. Accommodations are available in Minocqua. We'll talk about Squaw, Squirrel and other neat stuff at Thursday's meeting.

### Boat registration

The Illinois Department of Natural Resources is no longer sending expiration notices to boat owners so be sure to make sure you have up-to-date stickers. The fine for getting caught without registration is \$120. In another money saving measure, the DNR is allowing online registration site available at [www.dnr.illinois.gov/recreation/boating](http://www.dnr.illinois.gov/recreation/boating) and touch-tone phone renewals at 1-866-867-3542.

It may take a couple of months to get registration materials. Keep carbon copies of registration forms you filed or printouts from online registration with you when you're on the water.
